ABSTRACT

BACKGROUND & OBJECTIVE:

Persistent or secondary intraradicular infection is a major cause of post endodontic treatment disease. The effective removal of filling material from the root canal system is essential to ensuring a successful outcome of the retreatment procedure. The objective of the study is to evaluate the effectiveness of removal of thermoplasticized gutta-percha and epoxy resin based sealer with Wave one gold reciprocating file, Neoendo and Protaper universal retreatment rotary system and to quantify the volume percentage of thermoplasticized gutta-percha remnants and resin sealer in root canal using Cone Beam Computed tomography.

MATERIAL & METHODS

Forty-five extracted, human mandibular first premolars with single straight oval canals were radiographed and selected. The root canals were instrumented with the ProTaper universal system up to F1 and obturated with thermoplasticized gutta percha and resin sealer using elements system. After 1 month, the samples were randomly divided into three groups (n = 15) according to the retreatment system used: ProTaper Universal, Neoendo and Wave one gold. The specimens were scanned by a cone beam computed tomography device after the root filling and retreatment procedures, and analyse the volume percentage of filling material remaining in the root canal using cone beam computed tomography software

RESULTS:

The test results showed that Waveone Gold Retreatment files group showed significantly highest Volume percentage of filling material remaining as compared to ProTaper Universal and NeoEndo Retreatment files group at $P < 0.001$. However, no significant differences in the mean Volume percentage of filling material remaining were noted between ProTaper Universal and NeoEndo Retreatment files [$P = 0.26$].

INTERPRETATION & CONCLUSION:

Protaper Universal Retreatment system was more effective than the Neoendo retreatment files and Wave One Reciprocation file in the removal of thermoplasticized gutta-percha and epoxy resin-based sealer during the retreatment of oval root canals in extracted premolar teeth

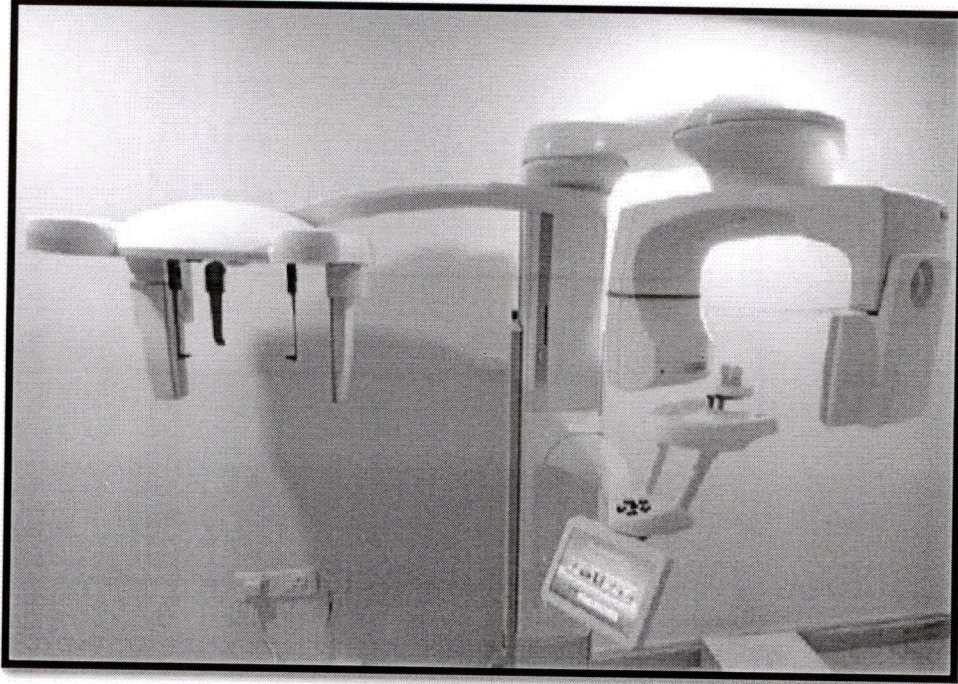

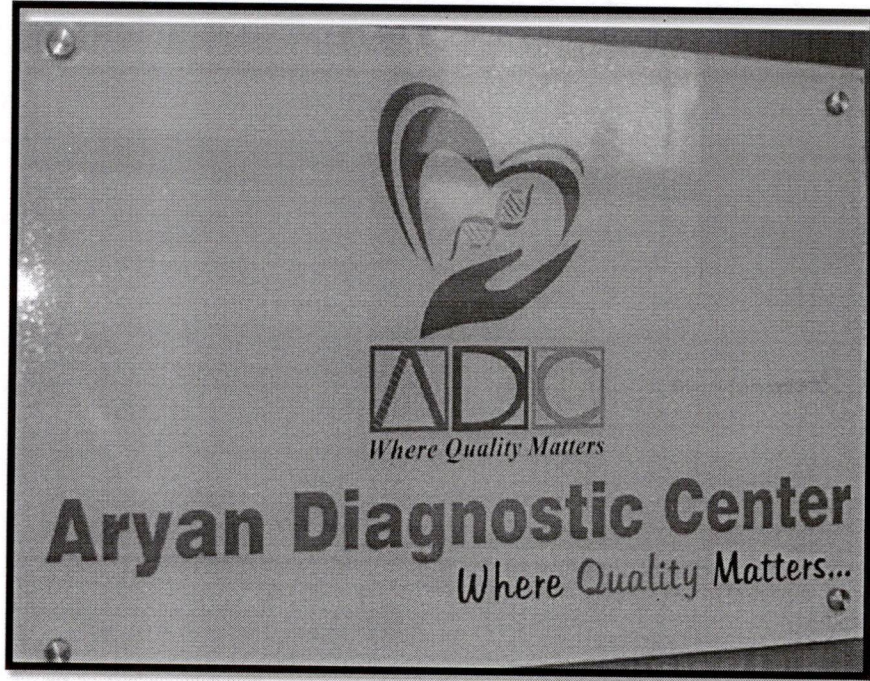

Abstract:

"Evaluation Of Association Between Maxillary Posterior Teeth Periapical Pathologies and Maxillary Sinus Mucosal Changes "- A Cone Beam Computed Tomography (CBCT) Study

Maxillary sinusitis is a globally prevalent disease which is mainly caused by allergies or respiratory infections. Due to the proximity of the roots of maxillary posterior teeth to the sinus floor, a substantial proportion of maxillary sinusitis cases have an odontogenic origin.¹The inflammatory changes in the mucosal lining caused by periapical infection can lead to the development of sinusitis. Various sinus abnormalities like mucosal thickening, sinus polyp, antral pseudocyst, nonspecific opacification, periostitis and antral calcifications have been associated with periapical lesions.²

A radiographic approach to diagnosis of odontogenic sinusitis is two-dimensional Intra Oral Periapical Radiographs (IOPAR), but limited by in-accuracy in location and extent of periapical lesions due to the superimposition of images of palatal root or zygomatic bone. Although Computed Tomography (CT) is the gold standard diagnostic technique for sinus pathologies, it is limited by low spatial resolution.³ Therefore, Cone Beam Computed Tomography (CBCT) with lower radiation dose and higher spatial resolution, may be helpful.³ Both axial and coronal views allow the clinician to assess the relationship of a periapical lesion to a sinus floor defect and any resultant changes in the soft tissues of the sinus. Hence, in this study, the association between maxillary posterior teeth periapical pathologies and maxillary sinus mucosal changes will be evaluated using CBCT imaging.
