Helinet fee amounting to Rs. 1,30,000/- is paid every year to Rajiv Gandhi University of Health Sciences, Bangalore towards E Journals and E Books.



## Rectification and Recruitment made to various Faculty Positions

Many Vacancies created in the cadre of Professor and HOD, Professor, Reader and Senior Lecturer. Consequent to the resignation and relieving of some of the faculty members were filled up by Interview Committee. Overseen and approved by the chairman. Overall 3 faculties were appointed for the Post of Professor and HOD in the departments of Periodontology, Prosthodontics and Public Health Dentistry. 1 Professor in the department of Conservative Dentistry, 1 Reader in the department of conservative, 1 Reader in the department of orthodontics were appointed and Senior Lecturers were appointed. Promotions were made for the post of Professor and Readers in the department of Oral Surgery and Orthodontics. Committee suggested towards rotation of HOD'S.

## Establishment of Comprehensive Dental clinic.

Chairman has taken the initiative towards establishment of Comprehensive Dental clinic on the ground floor of The Oxford Dental college. Estimated budget for interior designs is 50 lakhs. Procurement of 4 Dental chairs for patient treatment and 1 Dental chair for Diagnostic purpose. Faculty and Final year Post Graduate Students with good clinical skills will be posted.

Once in every three years Institutional Ethics Committee is reconstituted. Chairperson will continue Dr. Mohamed Faizuddin. Dr. Ashwija Shetty, Professor, Department of Conservative Dentistry is appointed as Member Secretary. Dr. Savitha A.M. Professor, Department of Periodontology and Dr. Mahamad Isfanulla Khan A.N. Professor, Department of Orthodontics are appointed as Members. Prior to submission to the Institutional Ethics Committee the Internal Scientific Committee will review the synopsis of the PG students and any Research projects. The IEC will be held for 2 Days and Final Ethical clearance certificate will be given.

The Proceedings of the Previous meeting held on 11/12/2023 was read out. The University Examination results was above 85% for UG and was 100% for PG Exams. A parent teachers meeting was conducted, IQAC was reconstituted and is functioning, AQAR for the year 2022-23



was submitted and approved by NAAC. Presently preparation of AQAR for 2023-24 is going on. In the All India ranking, the college participated in NIRF. The ranking was 29 in India Today, 28 in The Week and 11 in outlook magazine. Comprehensive Dental clinic has become fully functional with faculty attending to patients. The Journals procured were: 39 print journals for Rs. 18,91,331 and Helinet fee amounting to Rs. 1,30,000/- Paid to Rajiv Gandhi University of Health Science.

### Review of 2023-24.

**Admissions:** AS per the total intake of BDS admission, 100 students were admitted. Total MDS intake is 60 and 44 students were admitted.

**Academic Activities:** 138 programs were conducted for holistic development of students benefiting their Skill development, Progression, Knowledge enhancement, Orientation towards service to the Society, help them in career development.

**Academic Quality initiatives were taken:** The use of KAHOO! for quiz and E platform in teaching. Introduction to clinical relevance of topics/practicals from I BDS onwards. Initiation of OSCE and OSPE in practical / clinical teaching. Creation of E Content has begun. Faculty enrolled in the RAATI Foundation course.

Student Support and Progression: Students were encouraged to attend conferences and 104 presentations were made. Programs on competitive exam, career development / placements, Antiragging / Gender sensitization were conducted. Alumni meetings, Vaccination drive, and programs on stress management and depression were conducted. White coat ceremony, Cultural day and festivals were celebrated. In Bangalore, The Colgate Dental Student App was first launched at our college. A strong active mentorship program is in place (1:4)

Scholarship: Students applied for different scholarships namely National Scholarship (12), State Scholarship (48) Prevest Spark National Scholarship (3), 3 SC ST Students received laptops and cash prizes were given to the subject toppers from the Management (24).

Internal Assessment Reform: Slow learners identified, retests, remedial class, MCQ tests, open book tests were conducted. Interaction with parent / Guardian / Spouse and regular monitoring of attendance through ERP.

Results of the academic year 2023-24: BDS 85% in 1<sup>st</sup> year, 100% in 2<sup>nd</sup> year, 92% in 3<sup>rd</sup> year, 86% in 4<sup>th</sup> year, 100% in MDS results. Four University ranks.

Research: A number of programs such as Good Clinical practice, IPR workshop, Systematic reviews and meta-analyses were conducted. Sixty papers were published with only 31 were in Quality Journals. Few faculty have applied for research grants to Rajiv Gandhi University of Health Sciences and PG's have applied



for Student grants from ICMR.

Achievements: Four faculty received awards and 3 received fellowships. UGs and PGs participated in extracurricular activities and won 33 prizes.

Community Service: A total of 60 camps were conducted. Collaborations with various hospitals, NGO's, companies for delivery of oral health care. Outreach activities include 3 Denture camps at CIMS, Chamraynagar and other remote areas. World Oral Health Day was celebrated from 20<sup>th</sup> March for a month with various activities, competitions, walkathon, awareness programs and TV Talk. The clinical material in the college has increased from the previous year.

The Karnataka State ACE Conference was held in August 2023. Graduation Day, Kannada Rajyotsava Day, National Orthodontist week, Children's Day etc were celebrated. Several NSS activities were conducted. Official Social Media accounts for the college were created. A total of 16 Faculty were appointed and 2 promotions done, 3 Clerks and One lab technician were appointed.

Proposal for requirements and its approval

A budget of Rs 13,85,60,825 was presented for approval.

Infrastructure: classrooms: Upgradation with smart board / LED, furniture, audio / microscope and curtains. Change of furniture in the board room. Air conditioner to be replaced and LED projector in auditorium is required.

Digital lab: For oral rehabilitation, digital Scanners and 3D printing with Software. Requirement of 2 surgical Endodontic microscopes.

Biometrics: To be installed for UG's and PG's as per RGUHS.

Repair of existing dental chairs and replacing manual with electric chairs in a phased manner. Prosthodontic laboratory to be upgraded. Computers printers with scanning facility in departments.

Faculty Recruitment: 2 professor in the departments of Prosthodontics and orthodontics. Reader in the department of conservative (2), Periodontics (2) Oral Surgery (1) and Public Health Dentistry (2) and 8 Senior Lecturers. Two faculty to be promoted to Reader cadre in the department of Prosthodontics and Periodontics. Appointments of lab technician-02, Radiology Technician -01, Dental chair maintenance technician -01, System admin -01 to be appointed.

Performance appraisal and annual increment from June 2024 was put forth by the Member Secretary.



Prospective plan for 2024-25 was presented. Proposal to conduct a 1 year course on Implantology, Host a convention for house Surgeons and have a Symposium on "Cosmetic Dentistry for all ages". To invite clinicians of repute to impart hands on training. Faculty to publish a minimum of two papers per year in quality journals and write a research proposal for grants. To build a unique Skill development unit in every department making it their prime strength. All faculty, PGs and interns to register on NDR. To increase evidence based learning through case based learning and be prepared to incorporate NEP guidelines and follow NDC rules and regulations.

### Suggestions of the Governing Council Members:

The chairman instructed for rotation of HoD's. Sir advised to apply for research grants from major institutions and to develop the institution with focus on quality of Education.

### Student Feedback

Chairman interacted with Student representatives and gave a hearing to them. Dr. Bharani PG had requested chairman for intra oral scanner in the department of Orthodontics and for continuous water supply during college hours. Dr. Keerthi PG of Conservative Dentistry requested for Surgical endodontic microscope. Ms. Shambavi, III BDS Student expressed satisfaction with teaching and need for LCD projector in classrooms and cleaner wash rooms. Mr. Karthik, Final year BDS

Student thanked the management and teachers and requested for dental chairs to be repaired, for Smart class room and for Sports facilities. Chairman instructed the Principal and Manager to closely monitor the house keeping to maintain cleanliness and to educate girl students on washroom hygiene and water conservation. He also considered the request for intra oral scanner and Software in the college.

Dr. Laxmi Kanth was told that retrospective data could be stored on cloud using Tuno and a compactor would be needed for storing orthodontic models. He informed the student representatives of the management undertaking mega ongoing projects - the indoor stadium, cafeteria, auditorium and 250 bedded hospital.

Dr. Greenath Reddy suggested to increase number of publications in quality journals. Studies for dissertation should be clinical instead of invitro, retrospective and Survey studies. He suggested to form a research cluster and look at collaborations with other faculty of Oxford Institutions with similar field of interest. He suggested to select few faculty who are research oriented. Faculty should create E content on various platforms such as Swayam, MOOC, NPTEL.

Dr. Prabhuji, Dean of Dental Faculty, RGUHS spoke on the scope of faculty research projects and the benefits of digital scanners in departments. He mentioned the use of Digitabs for conduct of examinations. He also spoke of plagiarism software for all Oxford Institutions.
